If a cancellation by the company is made after payment of the total participation fee, the following guidelines will apply: (a) if written notification of exhibitor's cancelation is received by Concord Expo Group more than 140 days before the Opening Day of the show, then 50% of the total participation fee less a \$750 handling fee will be refunded to exhibitor; (b) If written notification of an exhibitor's cancelation is received by Concord Expo Group within 140 days of the Opening Day of the show, then the total participation fee will be forfeited by exhibitor. The participation fee is based on the current exchange rate and could be subject to adjustments, German regulations and VAT (Value Added Tax), if applicable.
